

**TERMS AND CONDITIONS:** Move to the comfort zone terms and conditions.

## **1. Description & Registration**

- 1.1 To showcase the benefits of migrating to Microsoft Windows 10 with a Lenovo modern device, the “Move to the comfort zone” Promotion the (“Promotion”) by Lenovo, is providing a Comfort Kit (The “Kit”) contains: a premium branded blanket and a Wacaco Minipresso.
